Keynote Speaker

Dr. Kathleen Kreiss received her MD from Harvard University. Since 1996 Dr. Kreiss has been Chief of the Field Studies Branch in the Division of Respiratory Disease Studies at the National Institute for Occupational Safety and Health. Prior to that she was on the faculty of the University of Colorado School of Medicine, directing an occupational residency program and conducting epidemiologic studies of respiratory disease in a broad range of industries. Most recently, Dr. Kreiss and colleagues at NIOSH have been evaluating respiratory disease in microwave popcorn production. Dr. Kreiss has received several awards for her research, including the 2007 Alice Hamilton Award for Excellence in Occupational Safety and Health from NIOSH.
